



RESOLUTION 2018-01 (02/21/2018)



WHEREAS, the Board of the Housing Authority of the Township of Haddon acting within its Authority and Obligation moves to approve the write-off of rent owed by former tenant Dennis Gordon, who resided in Apartment 705. Mr. Gordon's lease was terminated due to non-payment of rent as well as serious medical issues making it very difficult for him to continue to reside in Rohrer Towers I independently. He vacated his apartment on November 30, 2017.
